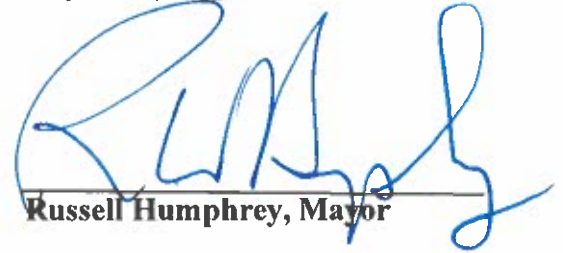
Mayor Pro Tem McKenzie adjourned the meeting without objection at 10:03 a.m.
